I understand that the Captain, Graham J. Ferguson or his trusted relief captains will have the final word on safety and will call this tour or charter short if inclement weather is deemed dangerous for the group on board. _____ (initial)

I agree to not hold the vessel "Island Hugger 1 and / or Captain Graham Ferguson of Long Point Island Hugger Tours or "Island Hugger 2" and / or Captain Greg Beemer of Through Natures Eyes Ponton Boating, the company staff or the locations the tour or charter destinations call to any liability to agents or other associated personnel responsible if I am injured as a result of ANY problems (medical, accidental or otherwise) which occur while chartering the boat or otherwise participating on the trip or tour. _____ (initial)
